# **Course Description**

Introduces programming language principles, including language constructs, design goals, run-time structures, implementation techniques and exposure to a wide variety of programming paradigms. 3 credits

#### Course Pre-Requisites / Co-Requisites

Prerequisite: COP 3530

#### **Course Objectives**

This course will discuss how programming languages are constructed and analyze the methodology used to create existing languages. Topics included are: lexical analysis, scanning, programmatic semantics, code generation, and different types of programming languages. Due to the nature and complexity of this field of study, the course will be time consuming and requires serious dedication on the part of each student. Be careful not to fall behind, success in this course requires consistent effort and practice.

The semester project is split into 6 graded milestones, building into the final submission. The two lowest milestone scores are dropped. The project is cumulative: each part of the project will require completion of the previous parts.

# **In-Class Recording**

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services.
